RE: "JUST BROTHERS" 2013 MYRTLE BEACH INVITATIONAL

Dear Brothers in Fellowship:

This letter is intended to communicate and confirm our plans for the 2013 Myrtle Beach Tournament. As in the past, we have decided to make our principle reservations at **Barefoot Resort & Golf** in North Myrtle Beach. The dates applicable for this spring are **April 20 - April 27, 2013**.

In making this year's arrangements, we kept in mind our last meeting in 2012 and some expressed concerns about lower cost alternatives. As a result, we have opted for the courses listed below, noting that we have committed to play at three different developments, two courses each, to capture the lowest total cost while preserving a diverse and high ranking set of good golfing locations:

The **golf cost options** for the 2013 package are as follows, per player:

\$694 Sunday thru Friday.

\$579 Monday thru Friday.

The **lodging cost options** for 2013 are as follows, per player:

\$428 Crescent Shores 3 bedrooms/3 players

\$367 Crescent Shores 4 bedrooms/4 players

\$395 Barefoot Towers 3 bedrooms/3 players

\$395 Barefoot Towers 4 bedrooms/4 players

\$295 Barefoot Villas 2 bedrooms (4 twin beds, 4 players)

Other benefits include:

Four (4) breakfast tickets worth a credit of \$7 each, applicable toward 4 restaurant choices (Hot Stacks, Spring House, Plantation Pancake or Dino's).

A breakfast and lunch, plus two drinks, are included at the Legends for each round played there (2).

One maid service visit mid week.

Given the choices we have this year, it's important that early confirmation be made in terms of location of stay and how many rounds. If we don't comply, our coordinator will turn back tee times and cancel room reservations to avoid excessive costs.

It is the Resort's requirement for reservations in advance. The initial deposit will be \$100 per player. Your deposit must to be registered by **no later than February 1, 2013**. Make sure you reference the Vernon Ford Group. **On that date, excess tee times and room reservations will be turned back!!**

Final payment is due April 1, 2013.

Roommate pairings should be made by you and communicated directly to the Resort by no later than **April 1 (no exceptions)**. For those players looking to be paired with a roommate, please let me know.

When we are a little closer to the tournament date, we will provide an update to confirm all last minute details, tournament rules and participants. In the interim, please review the email listing.
